## NOTICE OF ANNUAL GENERAL MEETING

Dear Shareholder

### 1. Introduction

I am pleased to be writing to you with details of the Company's Annual General Meeting, to be held at A1 Grainger, Prestwick Park, Prestwick, Newcastle upon Tyne, NE20 9SJ on 12<sup>th</sup> September 2023 at 2:00pm.

The purpose of this document is to set out the details of the ordinary and special business which is to be put to Shareholders at the AGM, to explain why the Directors consider the Resolutions to be in the best interests of the Company and Shareholders as a whole and to provide you with details of the AGM

### 2. Resolutions

Shareholders are being asked to vote on 10 Resolutions at the AGM. Resolutions 1 to 6 relate to the routine business of the AGM. Resolutions 7 to 10 relate to special business. The Resolutions are summarised and explained below.

#### **Resolution 1: Report and financial statements**

Resolution 1 is to receive and consider the Directors' and Auditor's Reports and Financial Statements for the year ended 31<sup>st</sup> March 2023.

#### **Resolution 2: Authority for the Directors to declare and pay a final dividend**

As a result of the strong performance in the financial year, the Board intends to recommence its dividend policy and the Directors propose the payment of a final dividend for the year ended 31<sup>st</sup> March 2023. The amount of dividend proposed is 4 pence per Ordinary Share. The dividend will be paid in two instalments of 2 pence each, on:

- a) the 15<sup>th</sup> September 2023, to the Shareholders at the close of business on 25<sup>th</sup> August 2023; and
- b) the 15<sup>th</sup> March 2024, to the Shareholders at the close of business on 23<sup>rd</sup> February 2024.

Accordingly, Resolution 2 authorises the Directors to declare and pay a final dividend for the year ended 31<sup>st</sup> March 2023.

#### **Resolutions 3 and 4: Re-Election of Directors**

Thomas Edward Hayes and Jeff Matthew Baryshnik are each standing for re-election, following their retirement by rotation pursuant to the articles of association of the Company.

### **Resolutions 5 and 6: Re-appointment of Auditor and remuneration**

Resolution 5 is for the re-appointment of Saffery Champness LLP as auditor of the Company.

Resolution 6 is to authorise the Directors to determine the remuneration of Saffery Champness LLP as auditor of the Company.

### **Resolution 7: Authority for the Directors to declare and pay a special dividend**

Having regard again to the strong performance during the financial year, the Board propose to distribute funds which are deemed surplus to strategic requirements. Accordingly, the Directors also propose a special dividend for the year ended 31<sup>st</sup> March 2023.

The amount of dividend proposed is 1 pence per Ordinary Share, to be paid on 15<sup>th</sup> September 2023 to the Shareholders at the close of business on 25<sup>th</sup> August 2023.

Accordingly, Resolution 7 authorises the Directors to declare and pay a special dividend. The approval of this resolution is not conditional upon the approval of Resolution 2, nor is the approval of Resolution 2 dependent upon the approval of Resolution 7.

### **Resolutions 8 and 9: Authority to allot shares and disapply pre-emption rights**

As part of its strategy, the Company continues to assess acquisition opportunities as they arise. The ability to issue shares for cash without the need for further shareholder approval will enable the Company to take advantage of such opportunities in a timely manner.

Accordingly, Resolution 8, which will be proposed as an ordinary resolution, renews the Directors' authority to allot up to 5,617,582 Ordinary Shares (representing 30 per cent. of the Issued Share Capital).

Resolution 9, which will be proposed as a special resolution, renews the Directors' power to allot up to 936,263 Ordinary Shares (representing 5 per cent of the Issued Share Capital), for cash, without first offering such shares to existing Shareholders. This special resolution also enables the Company, in the event of a rights issue or open offer, to overcome certain practical difficulties which may arise in connection with fractional entitlements.

The authorities conferred by Resolutions 8 and 9 shall expire at the earlier of the conclusion of the Company's annual general meeting held in 2024 or (if earlier) 30<sup>th</sup> September 2024.

### **Resolution 10: Authority for the Company to purchase its own shares**

The Directors consider it would be beneficial for the Company to continue to have the power to purchase its own shares in certain circumstances. If the authority were to be granted, the Company would be able to purchase its own shares and either cancel them (so reducing the total number of Company shares in issue) or hold them as treasury shares (if the shares were purchased out of distributable profits), subject to certain limitations.

Treasury shares themselves may be cancelled, sold for cash or transferred for the purposes of employee share schemes. All rights attaching to Company shares, including voting rights and the right to receive dividends, are suspended while they are held in treasury.

Resolution 10, which will be proposed as a special resolution, authorises the Directors to purchase up to a maximum of 936,263 Ordinary Shares (representing 5 per cent of the Issued Share Capital).

The maximum price per Ordinary Share payable on the exercise of the authority shall not be more than five (5) per cent above the average middle market quotations for the Ordinary Shares as derived from the London Stock Exchange Daily Official List for the five (5) business days prior to making any purchase. The minimum price payable shall be an Ordinary Share's nominal value, being 1 penny.

The authority will expire at the conclusion of the Company's annual general meeting to be held in 2024 or (if earlier) 30<sup>th</sup> September 2024.

The Directors will only implement purchases of Ordinary Shares if, after careful consideration, they are satisfied that such purchases are in the best interests of the Company and Shareholders generally and would result in an increase in expected earnings per share. Furthermore, account will be taken of the overall financial implications for the Company.

### 3. Recommendations

The Directors consider that all the proposals to be considered at the Annual General Meeting are in the best interests of the Company and its Shareholders as a whole. The Directors unanimously recommend shareholders vote in favour of the Resolutions set out in the notice of Annual General Meeting, as they intend to do in respect of their own beneficial holdings.

NOTICE IS HEREBY GIVEN that the annual general meeting of Northern Bear plc will be held at A1 Grainger, Prestwick Park, Prestwick, Newcastle upon Tyne, NE20 9SJ on 12<sup>th</sup> September 2023 commencing at 2:00pm for the purpose of considering and, if thought fit, passing thereat (or at any adjournment thereof) the following resolutions:

### Ordinary Business

As to the ordinary business of the Company, as follows:

- 1) To receive and adopt the Company's financial statements for the financial year ended 31<sup>st</sup> March 2023 together with the reports of the Directors and auditor thereon.
- 2) To authorise the Directors to declare and pay to the Shareholders a final dividend in respect of the year ending 31<sup>st</sup> March 2023 in an amount equal to 4 pence per Ordinary Share, which will be paid in two instalments of 2 pence each on:
  - a) the 15<sup>th</sup> September 2023, to the holders of Ordinary Shares at close of business on 25<sup>th</sup> August 2023; and
  - b) the 15<sup>th</sup> March 2024, to the holders of Ordinary Shares at close of business on the 23<sup>rd</sup> February 2024.
- 3) To re-elect Thomas Edward Hayes as a director of the Company.
- 4) To re-elect Jeff Matthew Baryshnik as a director of the Company.
- 5) To re-appoint Saffery Champness LLP as the Company's auditor to hold office from the conclusion of this meeting until the conclusion of the next meeting at which accounts are laid before the Company.
- 6) To authorise the Directors to agree the remuneration of the auditor.

### Special Business

As to special business (of which Resolutions 7 and 8 shall be proposed as ordinary resolutions and Resolutions 9 and 10 as special resolutions), as follows:-

- 7) To authorise the Directors to declare and pay to the Shareholders a special dividend in an amount equal to 1 pence per Ordinary Share, which will be paid on 15<sup>th</sup> September 2023 to the holders of Ordinary Shares at close of business on 25<sup>th</sup> August 2023.
- 8) That, in accordance with section 551 of the 2006 Act, the Directors be and they are hereby generally and unconditionally authorised to allot shares in the Company or grant Rights up to a maximum aggregate nominal amount of £56,175.82 PROVIDED THAT:
  - a) this authority shall (unless renewed, varied or revoked by the Company) expire at the earlier of the conclusion of the annual general meeting next held after the passing of this Resolution or 30<sup>th</sup> September 2024 (unless renewed or extended prior to or at such meeting); and
  - b) the Company may, before such expiry, make an offer, agreement or other arrangement which would or might require shares to be allotted or Rights to be granted after the expiry of such period and the Directors may allot shares or grant Rights in pursuance of any such offer, agreement or other arrangements as if the authority conferred hereby had not expired.

9) That, subject to the passing of Resolution 8, the Directors be and they are hereby given the general power to allot equity securities (as defined in section 560 of the said 2006 Act) for cash, either pursuant to the authority conferred upon them by Resolution 8 (as varied from time to time by the Company in general meeting) or by way of a sale of treasury shares, as if section 561(1) of the 2006 Act did not apply to any such allotment PROVIDED THAT:

a) this power shall be limited to:

- i) the allotment of equity securities in connection with a rights issue or any other pre-emptive offer in favour of holders of equity securities where the equity securities respectively attributable to the interests of all such holders are proportionate (as nearly as may be) to the respective amounts of equity securities held by them subject only to such exclusions or other arrangements as the Directors may consider appropriate to deal with treasury shares, fractional entitlements, record dates or legal and practical difficulties under the laws of or the requirements of any recognised regulatory body in any territory or otherwise or as regards shares held by an approved depository or in issue in uncertified form or otherwise howsoever; and
- ii) the allotment (otherwise than pursuant to sub-paragraph (a)(i) above) of equity securities up to an aggregate nominal value of £9,362.63; and

b) this power shall expire on whichever is the earlier of the conclusion of the next annual general meeting of the Company or 30<sup>th</sup> September 2024 (unless renewed or extended prior to or at such meeting); and

c) the Company may, before such expiry, make an offer, agreement or other arrangement which would or might require equity securities to be allotted after such expiry and the Directors may allot equity securities in pursuance of such offer, agreement or arrangement as if the power conferred hereby had not expired.

10) That the Company be and is hereby generally authorised to make market purchases (within the meaning of section 693(4) of the 2006 Act) of Ordinary Shares upon and subject to the following conditions:

a) the maximum aggregate number of Ordinary Shares which may be purchased is 936,263; and

b) Ordinary Shares may not be purchased at a price which is more than 5 per cent. above the average of the middle market quotations for the Ordinary Shares as taken from the London Stock Exchange Daily Official List for the five business days preceding the date of purchase (or at a price which is less than 1 pence per Ordinary Share),

and the authority to purchase conferred by this Resolution shall expire on whichever is the earlier of the conclusion of the next annual general meeting of the Company or 30<sup>th</sup> September 2024, save that the Company may before such expiry enter into a contract of purchase under which such purchase may be completed or executed wholly or partly after the expiration of this authority.

# NOTES TO THE NOTICE OF ANNUAL GENERAL MEETING

## *Defined terms*

- 1) Words and expressions defined in the document of which this notice of meeting forms part shall have the same meaning in this notice of meeting (save where the context otherwise requires).

## *Entitlement to attend and vote*

- 2) Only those members registered on the Company's register of members at:
  - a) close of business 6.00pm on 8<sup>th</sup> September 2023; or
  - b) if this meeting is adjourned, at close of business on the day which is two days prior to the adjourned meeting;shall be entitled to attend, speak and vote at the meeting. Changes to the register of members after the relevant deadline shall be disregarded in determining the rights of any person to attend and vote at the meeting.

## *Appointment of proxies*

- 3) If you are a member of the Company who is entitled to attend and vote at the meeting, you are entitled to appoint a proxy to exercise all or any of your rights to attend, speak and vote at the meeting and you should have received the Proxy Form with this notice of meeting. A proxy does not need to be a shareholder of the Company but must attend the meeting to represent you. You can only appoint a proxy using the procedures set out in these notes and the notes to the Proxy Form.
- 4) If you are not a member of the Company but you have been nominated by a member of the Company to enjoy information rights, you do not have a right to appoint any proxies under the procedures set out in these notes. Please read note 17 below.
- 5) Shareholders can:
  - a) appoint a proxy and give proxy instructions by returning the enclosed proxy form by post (see notes 10 and 11); or
  - b) if a CREST member, register their proxy appointment by utilising the CREST electronic proxy appointment service (see note 12).
- 6) Further details of how to appoint the Chairman of the meeting or another person as your proxy using the Proxy Form are set out in the notes to the Proxy Form. If you wish your proxy to speak on your behalf at the meeting you will need to appoint your own choice of proxy (not the Chairman) and give your instructions directly to them.
- 7) You may appoint more than one proxy, provided that each proxy is appointed to exercise rights attached to different shares. You may not appoint more than one proxy to exercise rights attached to any one share.
- 8) Appointment of a proxy does not preclude you from attending the meeting and voting in person. If you have appointed a proxy and attend the meeting in person, your proxy appointment will automatically be terminated.
- 9) A vote withheld is not a vote in law, which means that the vote will not be counted in the calculation of votes for or against a Resolution. If no voting indication is given, your proxy will vote or abstain from voting at his or her discretion. Your proxy will vote (or abstain from voting) as he or she thinks fit in relation to any other matter which is put before the meeting.

## *Appointment of proxy using hard copy proxy form*

- 10) The notes to the Proxy Form explain how to direct your proxy how to vote on each Resolution or withhold their vote.

To appoint a proxy using the Proxy Form, the form must be:

- a) completed and signed;
- b) sent or delivered to Link Group, PXS1, Central Square, 29 Wellington Street, Leeds, LS1 4DL; and
- c) received by Link Group no later than 2:00pm on 8<sup>th</sup> September 2023.



In the case of a member which is a company, the Proxy Form must be executed under its common seal (if applicable) or signed on its behalf by an officer of the company or an attorney for the company.

Any power of attorney or any other authority under which the Proxy Form is signed (or a duly certified copy of such power or authority) must be included with the Proxy Form.

- 12) CREST members who wish to appoint a proxy or proxies by utilising the CREST electronic proxy appointment service may do so for the meeting and any adjournment(s) of it by using the procedures described in the CREST manual (available via [www.euroclear.com](http://www.euroclear.com)) (the **CREST Manual**). CREST personal members or other CREST sponsored members, and those CREST members who have appointed a voting service provider(s), should refer to their CREST sponsor or voting service provider(s), who will be able to take the appropriate action on their behalf.

In order for a proxy appointment made using the CREST service to be valid, the appropriate CREST message (a **CREST Proxy Instruction**) must be properly authenticated in accordance with Euroclear UK & International's (EUI) specifications and must contain the information required for such instructions, as described in the CREST Manual. The message, regardless of whether it constitutes the appointment of a proxy or is an amendment to the instruction given to a previously appointed proxy, must, in order to be valid, be transmitted so as to be received by Link Group (CREST Participant ID: RA10) no later than 2:00pm on 8<sup>th</sup> September 2023, or, in the event of an adjournment of the meeting, 48 hours before the adjourned meeting. For this purpose, the time of receipt will be taken to be the time (as determined by the timestamp applied to the message by the CREST Applications Host) from which the issuer's agent is able to retrieve the message by enquiry to CREST in the manner prescribed by CREST. After this time, any change of instructions to proxies appointed through CREST should be communicated to the appointee through other means.

CREST members and, where applicable, their CREST sponsors or voting service providers should note the EUI does not make available special procedures in CREST for any particular message. Normal system timings and limitations will therefore apply in relation to the input of CREST Proxy Instructions. It is the responsibility of the CREST member concerned to take (or, if the CREST member is a CREST personal member or sponsored member, or has appointed a voting service provider(s), to procure that his/her CREST sponsor or voting service provider(s) take(s)) such action as shall be necessary to ensure that a message is transmitted by means of the CREST system by any particular time. In this connection, CREST members and, where applicable, their CREST sponsors or voting service providers are referred, in particular, to those sections of the CREST Manual concerning practical limitations of the CREST system and timings.

The Company may treat as invalid a CREST Proxy Instruction in the circumstances set out in regulation 35(5)(a) of the Uncertified Securities Regulations 2001.

#### *Appointment of proxy by joint members*

- 13) In the case of joint holders, where more than one of the joint holders purports to appoint a proxy, only the appointment submitted by the most senior holder will be accepted. Seniority is determined by the order in which the names of the joint holders appear in the Company's register of members in respect of the joint holding (the first-named being the most senior).

### *Changing proxy instructions*

- 14) To change your proxy instructions simply submit a new proxy appointment using the methods set out above. Note that the cut-off time for receipt of proxy appointments also applies in relation to amended instructions. Any amended proxy appointment received after the relevant cut-off time will be disregarded.

### *Termination of proxy appointments*

- 15) In order to revoke a proxy instruction you will need to inform the Company by sending a signed hard copy notice, clearly stating your intention to revoke your proxy appointment, to Link Group, PXS1, Central Square, 29 Wellington Street, Leeds, LS1 4DL. In the case of a member which is a company, the revocation notice must be executed under its common seal or signed on its behalf by an officer of the company or an attorney for the company. Any power of attorney or any other authority under which the revocation notice is signed (or a duly certified copy of such power or authority) must be included with the revocation notice.

The revocation notice must be received by Link Group no later than 2:00pm on 8<sup>th</sup> September 2023.

If you attempt to revoke your proxy appointment but the revocation is received after the time specified then, subject to note 8 above, your proxy appointment will remain valid.

### *Corporate representatives*

- 16) A corporation which is a member can appoint one or more corporate representatives who may exercise, on its behalf, all its powers as a member, provided that no more than one corporate representative exercises powers over the same share.

### *Information rights*

- 17) If you are a person who has been nominated under section 146 of the 2006 Act to enjoy information rights:
- a) You may have a right under an agreement between you and the Shareholder who has nominated you to have information rights (the **Relevant Member**) to be appointed or to have someone else appointed as a proxy for the meeting.
  - b) If you either do not have such a right or if you have such a right but do not wish to exercise it, you may have a right under an agreement between you and the Relevant Member to give instructions to the Relevant Member as to the exercise of voting rights.
  - c) Your main point of contact in terms of your investment in the Company remains the Relevant Member (or, perhaps your custodian or broker) and you should continue to contact them (and not the Company) regarding any changes or queries relating to your personal details and your interest in the Company (including any administrative matters). The only exception to this is where the Company expressly requests a response from you.

The rights relating to proxies set out in note 3 above do not apply directly to nominated persons.
